Date	Charge
At Enrollment	Annual Registration Fee (\$50 per dancer / \$75 family maximum)
1st of Every Month	Monthly Tuition (Automatic Payment)
10th of Every Month	\$15 Late Fee applied to unpaid accounts
November 15	First Costume Payment (\$60 per costume / \$75 Combo Class costume)
February 15	\$60 Remaining Costume Balance + Annual Recital Performance Package Due
Throughout the Season	Open Play Passes & Memberships (if applicable)
Competition Company	Company Bundle payments according to the Company payment schedule

Monthly

- Tuition processed automatically on the **1st** of each month.
 - Late fees are assessed after the **10th**.
 - Accounts that remain unpaid for **21 days** may result in:
 - Additional late fees- 10% per week delinquent
 - Suspension from classes
 - Costumes not being ordered
 - Costumes being withheld
 - Removal from classes until balances are current

- First Costume Installment
 - \$60 deposit per costume, \$75 for Combo Class costumes

February 15

- Final Costume Balance
 - \$60 per costume
 - Annual Recital Performance Package
 - First Dancer \$90
 - Each additional dancer \$50

Recital Tickets

Recital tickets will be available starting May15th. Families will receive detailed ticket information once the recital schedule is finalized.

Quick Reminders

- ✓ Tuition reserves your dancer's place in class.
- ✓ Tuition is divided into equal monthly payments and is not based on the number of classes in a particular month.
- ✓ All accounts are enrolled in automatic billing.
- ✓ Written withdrawal notice must be received by the **15th of the month** to avoid charges for the following month.
- ✓ Costumes cannot be ordered or distributed if an account has an outstanding balance.
- ✓ Competition Company fees are separate from recreational tuition and follow the Company payment schedule.
